> Inequalities at the Margins: Gender and Ethnicity in European societies Seminar Sommersemester 2016 Di 16.00 – 18.00: SH 4.108

Abstract

Comparative studies about social inequalities have typically focused on men – while women, migrants and other minorities were left at the margins. Studies about gender and ethnic inequalities are often restricted to single countries. More recently, however, international comparisons have become more central to understand patterns of gender and ethnic inequalities. Why do ethnic minorities face greater difficulties finding a job in some countries? Why is the gender wage gap in Italy smaller than in Germany? This course offers an overview of comparative studies about gender and ethnic inequalities focusing on European countries and the US. We will discuss how different institutional contexts and welfare states incorporate groups at the margins.

Requirements

Students are expected to read the articles and come to class prepared for discussion. Every student has to submit two discussion questions every week and send them by e-mail by Sunday evening. Each week one student or group of students will present one article assigned for the week (marked with * in the reading list), each student is responsible for one 15 to 20 minutes presentation for this course. Students who take the class "for grade" have to submit a seminar paper.
